M 11: 0 ARTICLES OF INCORPORATION

THE EFFINGHAM UNION CHURCH

OF EFFINGHAM, KANSAS

SECRE KANSAS

Board of WHEREAS, the members of the First United Methodist Church of Effingham, Kansas, and of the First Presbyterian Church of Effingham, Kansas, have voted their consent to uniting the two congregations into one corporate body under the laws of the State of Kansas:

NOW, THEREFORE, we the undersigned, incorporators, hereby associate ourselves to form and establish a corporation NOT for profit under the laws of the State of Kansas.

FIRST: The name of the Corporation is THE EFFINGHAM UNION CHURCH of Effingham, Kansas. What I have

SECOND: The location of its registered office in Kansas is the City of Effingham, Atchison County, 66023, and the resident agent in charge thereof at such address is David Bodenhausen.

To provide for the worship of Almighty God and instruction in the Christian religion by a united congregation which will share the property, real and personal, of the uniting churches and provide for the services of a Minister for the union church subject to the constitutions and disciplines of the United Methodist Church and of the United Presbyterian Church in the United States of America. To acquire, hold, use and dispose, sell, pledge, mortgage, invest and reinvest both in real and personal property and in trust to acquire, hold, use and dispose, sell, pledge, mortgage, invest and reinvest in real and personal property for religious, benevolent, charitable, educational and missionary purposes, both within and without the State of Kansas.

FOURTH: This Corporation shall not have authority to issue capital stock.

The affairs of this Corporation shall be managed by a Board

of twelve Directors who shall also be elected as and serve as a Board of Trustees. All shall be elected in the manner and for the term as provided for by the By-Laws of this Corporation.

Title to all church property shall vest in a Board of twelve Trustees consisting of the twelve Directors as set forth herein. The Board of Trustees shall meet at the same place and time as the Board of Directors, and the officers serving on the Board of Directors shall also serve in the same capacity on the Board of Trustees. The Board of Trustees shall have the power to acquire, hold, manage, pledge, sell, transfer and convey all such property. Full and complete conveyance of title to church property shall be evidenced by action of the president and secretary of the Board, or in such other manner as the Board may by resolution provide.

FIFTH: The conditions of membership and the right to vote shall be fixed by the By-Laws of this Corporation.
